- 1. The statement of financial results have been approved by the Board of Directors at its meeting held on August 02, 2022 and has been subject to limited review by Statutory auditors of the Company.
- 2. These financial results have been prepared in accordance with the recognition and measurement principles under Ind AS, as prescribed under Section 133 of the Companies Act, 2013 read with the Companies (Indian Accounting Standards) Rules, 2015 as amended, and other accounting principles generally accepted in India.
- 3. The Company operates in one reportable segment i.e. Automotive Fabrics.
- 4. EPS for the quarter ended June 30, 2022, March 31, 2022 and June 30, 2021 is not annualized.
- 5. The figures of the quarter ended March 31, 2022 are the balancing figures between the audited figures in respect of the full financial year and published year to date figures up to third quarter of the relevant financial year.
- 6. The unaudited financial results are rounded to the nearest crores, except when otherwise indicated. Amounts represented by '0' (zero) construes value less than Rupees fifty thousand.
- 7. The Government of India, on September 20, 2019, vide the Taxation Laws (Amendment) Ordinance 2019, inserted a new section 115BAA in the Income Tax Act, 1961, which provides an option to the Company for paying Income Tax at reduced rates as per the provisions/conditions defined in the said section. The Company has opted to continue with the old tax regime for the current financial year.
- 8. There is no dilution to the basic EPS as there are no outstanding potentially dilutive shares.
- 9. The Figures for the previous period/year have been regrouped/reclassified wherever necessary, to make them comparable.
